


#### **EDITORIAL**

t all times, the Engineer is called upon to solve technological problems, concrete and often complex, related to the design, production and implementation of products, systems or services. To assume such a strategic role in society, this professional must master a body of technical knowledge based on a solid scientific culture.

On a daily basis, the Engineer therefore pushes the limits of science to serve humanity. Such a responsibility cannot be assumed without adhering to fundamental values. This is why, in Cameroon, the exercise of the profession of Civil Engineer is based on competence, responsibility, a sense of ethics and social commitment. But also, any Civil Engineer who exercises his profession must be a member of the Order.

Being a member of a professional order is a privilege granted by Cameroonian society which recognizes the right of certain people to practice a particular profession. In return, to maintain its confidence in these professionals, the public expects them to provide their services in a competent and responsible manner.

Thus, the professional system of Cameroon recognizes that only Civil Engineers who are registered on the Roll of the Order have the right to perform the many professional acts reserved for the profession or, in other words, to practice as of Engineer.

This way of doing things is intended to preserve public confidence in professionals, including Engineers, since they offer their services to society. By protecting the public, the Order contributes to the reputation of integrity and professionalism that accompanies the title of Engineer.

But such a privilege entails obligations towards Cameroonian society. Thus the profession is regulated for one and the same purpose: to protect the public. In this chapter, Engineers are no exception. This is why in their professional activities, they are governed by the Law, the Internal Regulations and the Code of Ethics.

The National Order of Civil Engineers is precisely mandated by the Cameroonian Government to ensure that all respect this legislation.

#### THE ENGINEER AND SOCIETY

#### ► Abstract

A paper prepared by Engineer Emeritus Michael Ajua Alemanji. The topic for this presentation should not be confused with the Engineer in society, because the Engineer in society is just an ordinary citizen.

However, the Engineer and society is a reflection of the relationship between the Engineer and the activities or services which he can render to the society he lives in.

But then we may ask, who is an Engineer? In 1868, John Seymour Lucas during a conference of Engineers at Menai Strait, Wales, said, "an Engineer is a professional practionner of engineering concerned with applying scientific knowledge, mathematics and ingenuity to develop solutions to technical and practical problems".

The word "Engineer" is derived from the latin root **Ingenium** meaning "cleverness". The mission of Engineers is to transform the face of the earth, conceive, design, build, maintain and control the putting in place of infrastructure of all kinds for the advancement of mankind

This write up is an attempt to demonstrate how the Engineer has used his technical know-how to advance the frontiers of the socio-economic development of society. By transforming the innovative creative project ideas conceived by their predecessors into reality, the Engineer improves the living standards for mankind.

This write up will examine in summary form how marrying their technical know-how and the political will to develop, based on economic imperatives has transformed the project ideas, once considered as myths into reality.

For example, when in 1802, the French Engineer, Albert Mathieu, first mooted the creative idea of building a tunnel to connect France on mainland Europe with Island Britain (he must have been dismissed for a dreamer).

Fortunately, economic imperatives forced the French and the United Kingdom governments to award a franchise for 50 years to a consortium Eurotunnel to construct and operate the tunnel (on a build operate and transfer-BOT).

We shall also examine what has become known as the Indian Telecommunication miracle. The Indian Prime Minister Rajiv Gandhi invited Sam Pitroda, a US-based non-resident Indian and requested him to set up a centre for the development of telematics to manufacture electronic telephone exchanges in India for the first time. Today India, with a subscriber base of more than 1,151 million mobile telecommunications system, is the second largest in the world.

When a road accident caused the Mungo Bridge to collapse on July 1st 2004, Cameroon Engineers guickly proposed and installed a temporary bridge using a large pontoon from the Cameroon Shipyard and Industrial Engineering Company in Douala.

An Emeritus Cameroon Engineer and economist has researched the problems facing our society on the street, and published a pionnering text book "The city street in Cameroon", a quide to street and city management. His creative innovation is the proposal to construct a six lanes supper highway linking Bekoko junction on the Douala — Tiko, Douala - Bafoussam highway to the entrance of Dibamba bridge on the Douala — Yaounde highway.

While complying with the terms of the 2020 action plan presented and approved by the General Assembly meeting held in Yaoundé on 22 February 2020, the Council of the Order had been active in making sure that the activities envisaged (and most especially the celebrations of the 20th anniversary of the Order), were carried out in spite of the difficult health context marked by COVID-19.

Since it was not authorised to organise a General Assembly meeting in 2021, the Council of the Order adopted, at the beginning of the 15 January 2021 session, to implement the major headings of its recurrent budget based on the principle of "provisional twelfths" and to obtain exceptional authorisations in view to carry out certain activities deemed indispensable and not featuring in the 2020 action plan or budget reconfirmed for 2021.

#### FINANCIAL MANAGEMENT IN 2021

Measures taken by the government and related to the current health situation did not allow for the holding of the Annual Meeting of Civil Engineers, given that the Order has a membership of 3,000.

The Council of the Order therefore decided that during that interval, the President of the Order be authorised to ease the smooth running of the General Secretariat and the regional representations based on the principle of provisional twelfths.

However, for actions deemed important in promoting and defending the interests of Civil Engineers, exceptional authorisations shall be given to the President of the Order.

Such authorisations relate mainly to the holding of regional meetings for the installation regional representatives, and the swearing-in of Engineers newly registered into the Roll of the Order; the investigation mission on the initial training of Engineers in Burkina Faso; refurbishment of the headquarters building and production of the Engineer's stamp.
